The purpose of Internet access through the campus network is to reflect and support the mission and objectives adopted by the College (see RCC College Catalog). All students, faculty, staff, and public patrons are expected to use RCC's Internet resources in a lawful and ethical manner. Use of the Internet is a privilege, not a right, and interference with RCC's mission will result in cancellation and/or loss of the privilege.

This use is granted subject to state laws, including but not limited to, North Carolina General Statutes, Article 60, "Computer-Related Crime," Chapter 14:453, 457: and federal laws, including but not limited to, Computer Fraud and Abuse Act of 1986, Computer Fraud and Abuse Act of 1994, Computer Matching and Privacy Protection Act of 1988, Computer Security Act of 1990, and subsequent amendments to these laws. Copies of laws and acts are located at the circulation desk.

1. Users must read and sign an Internet and Computer Network User Policy and sign a log-in sheet. Students, faculty, and staff must display a current RCC ID at the workstation, and public patrons must display a valid NC picture ID. Users must log out.
2. Users must be 16 years or older (Exception: Early College) to use the computers. Children under 16 must be accompanied and supervised by a parent or guardian while in the library.
3. No chat groups, no e-mail (unless for a RCC class), no games nor game-related websites, and no pornography, offensive or inappropriate materials will be allowed.
4. No open food or beverages are allowed. All packaged food and beverages should be out of sight.
5. Cell phones must be silenced in library/lab, and no calls received or made onsite. Electronic/listening devices are prohibited, except in cases involving documented disability or impairment.
6. Users must not attempt to erase or alter system files or computer settings.
7. Users are required to supply own storage devices.
8. Do not install personal software, shareware, or freeware, nor conduct personal business such as shopping and banking online. Only academic requirements allowed.
9. The Internet may not be accessed for any illegal activity or profitable gain. Users may not violate copyright laws and/or fair use provisions by downloading pirated or illegal material, including software and music files.
10. RCC students are allotted a 4-hour time frame per day to complete all assignments. Other users 2 hours per day. Unattended computers (15 minutes or longer) will be reassigned to another user.
11. Disruptive behavior is not allowed.
12. A cost of 10¢ per black/white copy and 50¢ per color copy will be charged to offset printing costs. Users will be responsible for all copies printed.
13. Robeson Community College Library/Lab does not support and is not liable for any inappropriate material accessed by Internet that may prove to be in conflict with the RCC Internet and Computer Network User Policy.
14. Robeson Community College Library reserves the right to modify this policy at any time as technological changes occur, or need arises.
15. Failure to comply will result in loss of privileges. Users will be asked to sign an Internet Suspension Form.
