UPON COMPLETION OF THIS 24-HOUR COURSE, STUDENTS WILL HAVE THE SKILLS NECESSARY TO PRODUCE A VARIETY OF ANALYTICAL PRODUCTS THAT DETAIL EVERY ASPECT OF A CRIMINAL ENTERPRISE, FROM HOW THEY ARE CONNECTED, TO THEIR SOCIAL NETWORK AND PATTERNS OF LIFE, AND HOW TO USE THIS INFORMATION TO SET UP FUTURE OPERATIONS. THESE ANALYTICAL PRODUCTS INCLUDE; ASSOCIATION MATRICES, LINK ANALYSIS DIAGRAMS, TELEPHONE TOLL DIAGRAMS, AND TIME EVENT CHARTS. STUDENTS WILL ALSO HAVE AN EXCELLENT UNDERSTANDING OF THE CRIMINAL INTELLIGENCE ANALYSIS PROCESS AND WILL POSSESS THE NECESSARY SKILLS TO PROPERLY EXPLOIT DOCUMENTS. STUDENTS WILL ALSO UNDERSTAND HOW COMPUTERS CAN BE USED TO PERFORM ANALYTICAL FUNCTIONS IN SUPPORT OF LAW ENFORCEMENT AND OTHER ORGANIZATIONS.
