Specific Areas of Support

Unrestricted Funds:

Funds that are not specifically designated to particular uses by the donor. These funds (also called Discretionary Funds) entrust the Foundation Board of Directors with responding to changing needs and emergencies of the Foundation, to support the creation of innovative responses to Foundation issues, and to enhance the quality of the Foundation.

Program Funds:

These funds are tax-deductible but can't benefit a donor or specific individuals. These funds will ONLY cover expenses within a department, club, or organization that support the institution's mission (according to U.S. Internal Revenue Service regulations).

Well Being Funds:

These funds will be used to cover expenses associated with day-to-day operations within a department, club, or organization. Contributions to these funds ARE NOT tax deductible because the donor or specific individuals are receiving benefits in return for the contribution (according to U.S. Internal Revenue Service regulations).

Endowed Scholarships:

Scholarships that memorialize and honor loved ones and special friends while supporting students who could not otherwise attend Robeson. Endowed scholarships of \$10,000 or more may be named in honor of an individual, family or any entity. The award of the scholarship is based on the interest accrued on the investment. There are several designated endowed scholarships already established with the Foundation that may be of interest to you.

Annual Scholarships:

These scholarships are funded with annual cash gifts from donors. Annual scholarships are named in honor of individuals, families, organizations, clubs, student organizations, and many other entities. There are several annual scholarships that may be of interest to you.
