- For Surgical Technology, **the GPA will be based upon grades earned in** BIO 168, BIO 169, BIO 275, ENG 111, PSY 150, Humanities/Fine Arts elective (HUM 115 or PHI 240).
- The Surgical Technology Program Faculty will **not** receive student packets for review if the GPA is less than 2.8 in Surgical Technology general education/related courses.
- Students may earn points for admission based upon a final course grade in HSC 110, MAT 143, and MED 120; however, the courses **are not** considered in the calculation of GPA for admission.

Eligible transfer/equivalent courses may be considered. These courses **will not** be considered in the calculation of program GPA for admission.

Part II Participation in Program Information Session

Applicants **must submit a signed certificate** of participation in a Surgical Technology Information Session with the application. The program director, program faculty or designee will provide a signature that denotes the applicant’s attendance in a program information session.

- Signed Information Session Certificate – A maximum 2 points (only one certificate will be considered).

Part III References

Each applicant must submit three references on forms provided by the Admissions Office. **The only references that will be awarded points are high school teachers, college faculty and employers.** A maximum of 1 point will be awarded for each reference (total of 3 points). Completed rating forms should be submitted (in sealed envelopes) with all other admissions materials.

Part IV Provisional Acceptance

1. A point selection process will be used to rank applicants for provisional acceptance into the program. Only applicants who have completed all the admissions requirements/criteria will be ranked for review. Particular consideration will be given to those applicants who have successfully completed the general/related education courses for the program or appropriate high school courses.
2. **Applicants must have a 2.8 or greater grade point average (GPA) in program general education/related courses at the time of the application submission to Admissions in order to be considered for health science program admission.**
3. Robeson Community College health science faculty will review the achievement potential of each applicant. During the candidate review process, faculty will examine previous academic records and pre-entrance examination scores to determine congruence with curriculum academic demands and program expectations.
4. Top applicants will be required to attend a final information session hosted by Surgical Technology faculty in July. Notification of this session will be sent by mail. This session is designed to provide applicants with additional program requirements. Applicants who are chosen for the program are offered provisional acceptance based on fulfillment of all admission requirements/criteria by the deadline specified in the provisional acceptance letter.

Part V Provisional Acceptance Requirements

Prior to receiving full acceptance and/or enrolling in the first surgical technology course, all Applicants Provisionally accepted **MUST** complete and/or provide documentation of the following:

Requirement	Description
Medical Screen	<p>A complete medical/ health screen provide by a licensed provider is required. The screen includes but not limited to:</p> <ul style="list-style-type: none"> a. Two (2) separate PPDs: Proof of Negative Tuberculin (Tb) skin testing or follow-up chest X-ray within 3 months of enrollment. b. Immunizations <ul style="list-style-type: none"> ▪ <u>T-dap</u>, tetanus vaccines, Hepatitis B series, MMR, Rubella, Varicella series or positive titer (required) ▪ Influenza, although not required but strongly recommended and/or required by clinical affiliate
Criminal Background Check and Drug Screen:	<p>Clinical agencies require a criminal background check and 12 panel urine drug screen prior to clinical experiences.</p> <ul style="list-style-type: none"> a. If results of a criminal background check and panel urine drug screen prevents a student from participating in a clinical experience at any agency, then the student will not be able to fulfill the clinical requirements for the program, and subsequently will not be allowed to enroll/ complete the Surgical Technology program. b. This testing is scheduled by the College once Applicants have been provisionally accepted. However, fees associated with the criminal background check and drug screen will be the responsibility of the student.
Healthcare-Provider CPR	<p>Documentation of current/active American Heart Association - BLS Healthcare Providers CPR certification (including infant, child and adult certification).</p>
Orientation	<p>To be scheduled. Attendance is mandatory & required for full acceptance.</p>
Program Prerequisites	<p>Submit documentation of successfully completing the following courses with a “C” or higher:</p> <ul style="list-style-type: none"> ▪ BIO 168 Human Anatomy & Physiology I
