NOTICE TO STUDENTS

1. WHEN MOVING VEHICLES SHOULD BE YOUR FIRST OPTION (14 hours)

Friday 630pm-830pm, Saturday 8am-5pm & Sunday 8am-12pm

This class will consist of real-world tactics which are used to move vehicles in a controlled and safe manner while still occupied. The class will also demonstrate how to give up a few minutes on the front end of an extrication to gain time back in an extrication. Multiple rescue tools will be utilized.

30. CHIEF 101 (8 hours)

Saturday 830am – 530pm

This class will satisfy the 9S inspection criteria as specified by the North Carolina Administrative Code. The primary objective of the course is to inform current and future chief officers of the various aspects and complexities surrounding the operations and organization of North Carolina fire departments. Emphasis will be placed on ratings and inspections, NFIRS reporting, prevention and grant programs, basic line-of-duty death information, financial considerations, and an overview of the various expectations facing a chief officer.

31. CHIEF 101 REFRESHER (4 hours)

Friday 600pm-10pm

Refresher course for those who have already taken the full 8-hour course.

32. FIRE OFFICER I (40 hours)

Wednesday 1pm-10pm, Thursday 8am-6pm, Friday 8a-6pm, Saturday 8am–6pm & Sunday 8am–1pm

This course identifies the performance requirements necessary to perform the duties of a first line supervisor. This course introduces the student to the basic concept of management and supervision. 36. Critical Incident Stress Management Training 2/10/23 – 2/12/23 0800 – 1700

THIS COURSE IS DEDICATED TO THE MEMORY OF MR. BILLY WARWICK

The CISM GRIN Class is a combination of both the Individual Crisis Intervention and Peer Support & Group Crisis Intervention. This course is designed for EAP, human resources and public safety personnel, mental health professionals, chaplains, emergency medical services providers, firefighters, physicians, police officers, nurses, dispatchers, airline personnel and disaster workers who are already trained in the critical incident stress debriefing format. It will also be useful for those working extensively with traumatized victims for various walks of life. Additional Fees: Books \$55. Certificate \$5. Limited scholarships available to cover these fees.

36. NAEMT - Tactical Emergency Casualty Care (TECC) 2/9/23 – 2/10/23 0800 – 1700

The 2nd edition of NAEMT's Tactical Emergency Casualty Care (TECC) course teaches EMS practitioners and other prehospital providers how to respond to and care for patients in a civilian tactical environment. The course presents the three phases of tactical care and integrates parallel EMS nomenclature: Hot Zone/Direct Threat Care that is rendered while under attack or in adverse conditions. 38. NAEMT – Prehospital Trauma Life Support (PHTLS) 2/9/23 – 2/10/23 0800 – 1700

NAEMT's Prehospital Trauma Life Support (PHTLS) is recognized around the world as the leading continuing education program for prehospital emergency trauma care. The mission of PHTLS is to promote excellence in trauma patient management by all providers involved in the delivery of prehospital care. PHTLS is developed by NAEMT in cooperation with the American College of Surgeons' Committee on Trauma. The Committee provides the medical direction and content oversight for the PHTLS program.

PHTLS courses improve the quality of trauma care and decrease mortality. The program is based on a philosophy stressing the treatment of the multi-system trauma patient as a unique entity with specific needs. PHTLS promotes critical thinking as the foundation for providing quality care. It is based on the belief that, given a good fund of knowledge and key principles, EMS practitioners are capable of making reasoned decisions regarding patient care.

PHTLS is appropriate for EMTs, paramedics, nurses, physician assistants, physicians, and other prehospital providers. Additional Fees: Certification \$15.

39. NAEMT – Advanced Medical Life Support (AMLS) 2/11/23 – 2/12/23 0800 – 1700

Advanced Medical Life Support (AMLS) remains the gold standard of education for emergency medical assessment and treatment. Endorsed by the National Association of EMS Physicians, AMLS emphasizes the use of the AMLS Assessment Pathway, a systematic tool for assessing and managing common medical conditions with urgent accuracy.

In the third edition of AMLS, students learn to recognize and manage common medical crises through realistic case-based scenarios that challenge students to apply their knowledge to highly critical patients. The course emphasizes the use of scene size-up, first impression, history, interactive group discussion on differential diagnosis and potential treatment strategies, and physical exam to systematically rule out and consider possibilities and probabilities in treating patients' medical crises. The third edition AMLS library of patient simulations offers students an opportunity to apply critical thinking skills to a variety of patient presentations.

40. INITIAL FIRE INVESTIGATIONS FOR FIRST RESPONDERS (16 hours)

Friday 6pm-10pm, Saturday 8am-5pm & Sunday 8am-12pm

This course provides a clear definition of the role of initial responder to recognize the potential of an intentionally set fire, preserve evidence, and properly report the information to appropriate officials. Basic topics include: fire behavior, critical observations of the first responder, fire cause, scene security and evidence preservation, legal considerations, and the reporting of findings.

41. LEADERSHIP IN SUPERVISION: CREATING ENVIRONMENTS FOR PROFESSIONAL GROWTH (16 hours)

Friday 6pm-10pm, Saturday 8am-5pm & Sunday 8am-12pm

This course presents the supervisor with the basic leadership skills and tools needed to perform effectively in the fire service environment and includes concepts related to a successful transition to supervisory and leadership roles, including concepts of adaptive leadership; change management; active followership; effective communication, including difficult conversations and advocacy-inquiry-based dialogue; ethics; authority; power; decision making; and active engagement through development of a personal plan.

42. LEADERSHIP IN SUPERVISION: PERSPECTIVES IN THINKING (16 hours)

Friday 6pm-10pm, Saturday 8am-5pm & Sunday 8am-12pm

This course provides the supervisor with the conceptual foundation and framework for success in leadership roles by exploring creative, analytical, political and critical thinking perspectives and addresses skills needed for assessing situations from multiple perspectives, making critical decisions, fostering creativity and innovation, and using persuasion.





NON-CERTIFICATION

43. EXPLOSIVES, BOMBS & BOOBY TRAPS (15 hours)

Friday 7pm-10pm., Saturday 830am – 500pm & Sunday 800am-1pm

This class takes Emergency First Responders (EMS, Fire, Law Enforcement, and Rescue) through basic understandings of explosives, explosive environments and understanding how they function. The latest Improvised Explosive Devices (IEDs) being employed overseas and domestically, how they are constructed, the damage they can cause, and how they are being used by terrorists against first responders. Also, what first responders can do to ensure their safety against this new threat. The course will take the students through bomb threats, searches, and booby traps, all of which they may encounter in their jobs. It will also discuss ways to discover terrorist methods, activities and the latest cases and ways they can help stop future events in the U. S. This course will be presented through classroom instruction and practical exercises including bomb searches, booby trapped trails, and live explosive demonstrations.

44. FATAL FIRE INVESTIGATIONS (12 hours)

Saturday 830am – 500pm & Sunday 800am – 1pm

This course aids in all parts of fire and law enforcement investigations into any type of fatal fire and will go over many avenues of responsibility of each party and will help everyone with the scene and follow up.

45. ADVANCED FIREFIGHTING TECHNIQUES (20 hours)

Friday 1pm-10pm, Saturday 8am-5pm & Sunday 8am-12pm

Minimum age requirement is 18 years old. Full PPE with SCBA is required.

This course is designed for the experienced firefighter to practice suppression techniques in a variety of live fire scenarios. Instructors will incorporate the use of LP gas props, rail car, burn trailer and class A burn building. **NC OSFM Live Fire Course Competency Validation Form 200.14a (on the back of the registration form) MUST be completed in order to enroll!**

46. NFPA 1403 ACADEMY (22 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8am-1pm

This course is designed for the firefighter with little or no experience. Basics to be covered include fire streams, SCBA, hose practices, building construction, ladders and fire behavior. Practical applications will be used. This class meets the minimum qualifications for NFPA 1403.

Needs: Full PPE

47. LAND NAVIGATION (20 hours)

Friday 6-10 p.m., Saturday 8 a.m. – 7 p.m., & Sunday 8 a.m. – 2 p.m.

This class will consist of the use of GPS and compass over terrain and how to determine your location while on a mission. There will be practical exercises for the student to become familiar with both of these tools for search activities.

Needs: Compass

48. NC RATING RESPONSE SYSTEM (12 hours)

Saturday 830am – 500pm & Sunday 800am-1pm

A representative from the NC Department of Insurance will discuss the new rating response system program and how it relates to the ISO system. Learn how your department will be rated in the future.

Needs: Calculator, paper, No. 2 pencils, map of your service area with all hydrants, and apparatus inventories on all trucks in your department.

49. ERDI 1 AND DIVE TENDER OPERATIONS (22 hours)

Friday 6pm-10pm, Saturday 8am-9pm & Sunday 8am-3pm

This rescue diver certification is designed to develop the knowledge and necessary skills for an individual to effectively perform diver rescues and assists, the function of a dive tender, and performing underwater search patterns.

Note: Class will meet on main campus Friday evening and be at off site locations Saturday and Sunday.

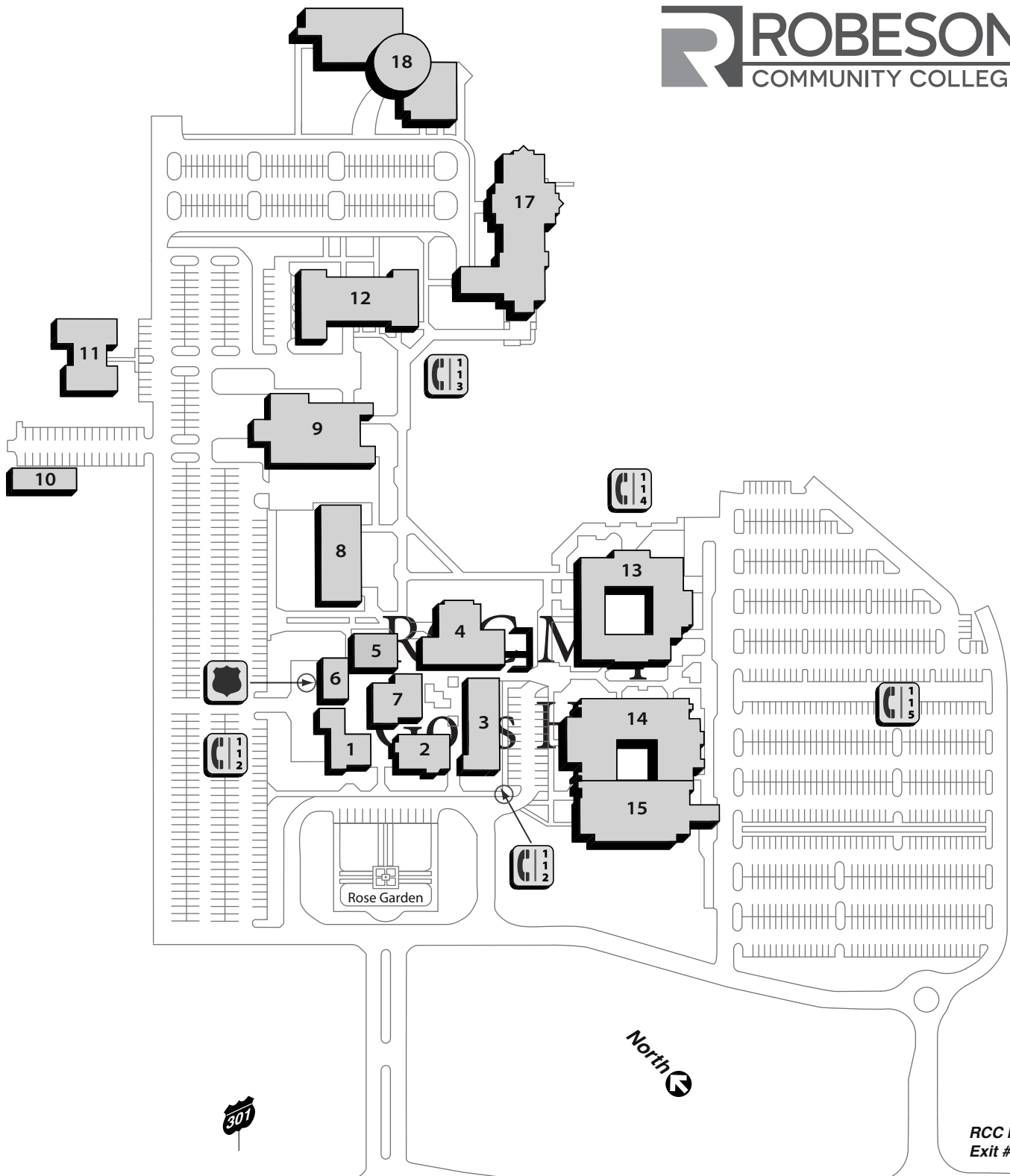
